Attention:

AIS

- 1. Document must be submitted by parents or school representative, enclosed with authorization letter.
- 2. All photocopied / scanned / printed documents must be endorsed / certified by Embassy.
- 3. Original documents are compulsory for verification.
- 4. Immigration officer is entitled to ask for additional documents if necessary.
- 5. Only completed application will be accepted and processed.
- 6. Applicant and guardian may be called for interview by immigration officer.
- 7. AIS is not responsible for any rejection/ non-approval of application.
- 8. The period of application varies for every application.

Non-approval Conditions:

- 1. Student below age of 6. Only age 6-17 will be eligible to apply.
- 2. Single parent who is divorced or no official marriage certificate is not eligible to apply.
- 3. Student with both deceased parents is not eligible to apply.
- 4. Only Mother is allowed to apply as guardian.
- 5. Father holding temporary pass and spouse visa is not eligible to apply.
- 6. Parent holding student visa (PhD/Master), only student can apply.
- 7. Father holding: i) Category 1 (salary above RM10K) both student and parent cannot apply
 - ii) Category 2 (salary RM5-RM10K) only student can apply
 - iii) Category 3 (salary below RM5K) both student and parent cannot apply
